

**2021 KOBİ-TV NBC5/KOTI-TV NBC2 GRANTS PASS DOWNS SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE REQUIRED TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING A PRIZE. VOID WHERE PROHIBITED.

OVERVIEW/SWEEPSTAKES PERIOD: KOBİ-TV NBC5/KOTI-TV NBC2 Grants Pass Downs Sweepstakes (the "Sweepstakes"), solely sponsored by KOBİ-TV/NBC5 (NBC5) begins on Wednesday, September 15, 2021 at 12:01:00 a.m. Pacific Daylight Time ("PDT") and ends on Wednesday, September 22, 2021 at 9:59:59 a.m. PDT (the "Sweepstakes Period"). The Sweepstakes is subject to all applicable federal, state and local laws and regulations. By participating, you agree to abide by, and be bound by, these Official Rules and the decisions of the judge's panel, which shall be final and binding in all matters relating to the Sweepstakes.

ELIGIBILITY: The Sweepstakes is open to all Southern Oregon and Northern California residents within the Medford/Klamath Falls broadcast DMA (Designated Market Area which consists of the following counties: Jackson, Josephine, Siskiyou, Lake, Curry, and Klamath) and in the significantly viewed Oregon counties of Coos and Douglas, who are 18 years or older at the time of the Sweepstakes. The Sweepstakes is not open to staff members of KOBİ-TV NBC5/KOTI-TV NBC2, their respective affiliates, subsidiaries and advertising or promotional agencies, or to the immediate family members of, or any persons domiciled with any such staff members. For purposes of the Sweepstakes, "immediate family members" are defined as entrant's spouse, parents, children, siblings, grandparents and grandchildren. WINNER ANNOUNCEMENT: Each Friday at 10AM during the sweepstakes, a random drawing of all eligible entries will be conducted to determine the weekly winners. Each potential winner must meet all eligibility requirements set forth in these Official Rules and comply with these Official Rules to qualify for the prize. Winners will be announced on the KOBİ-TV Sweepstake page.

PRIZES AND PRIZE DRAWING:

Week 1 - Three winners: Each winner receives Two Season Passes - Drawing Friday, September 17 at 10am

Week 2 - Three winners: Each winner receives Four Day Passes – Drawing Friday, September 24 at 10am

Week 3 - Three winners: Each winner receives Four Day Passes - Drawing Friday, October 1 at 10am

Week 4 - Three winners: Each winner receives Four Day Passes - Drawing Friday, October 8 at 10am

ODDS: The odds of winning a prize depend on the total number of eligible Entries received during the Sweepstakes Period.

No cash redemption or other substitution or prizes allowed, in whole or in part, except as provided herein. The winners are responsible for all federal, state and/or local income taxes on their prizes. All prizes will be awarded provided they are claimed properly in accordance with these Official Rules.
