WINNER DRAWING AND ANNOUNCEMENT: On Friday, November 3, at 10:0:0 a.m. a random drawing of all eligible entries will be conducted to determine the winners. Winners will be announced on the KOBI-TV Ruben & Clay Ticket Give-Away page.
